3. Nomination:

As per Rule 15(i), every Member of UWA can file nomination for the post of Office Bearer or Executive Member.

- 4. Election will be held by "Secret Ballot".
- 5. One member will be eligible to contest only for one post.
- 6. Withdrawal and re-nomination from one post to another is allowed simultaneously.
- 7. No proxy will be allowed.
- 8. One Flat one Vote policy shall be adopted.
- 9. In case of Trust ownership, authorisation letter by any of the trustees and in case of Company ownership, the Managing Director / Director or a person duly authorised by the Company will be eligible to vote. Similarly, in case of LLP or Partnership Firm, the authorisation should be from the Designated Partner / Managing Partner / Partner.
- 10. Format of Nomination Form, Withdrawal Form, Declaration Form and associated details will be issued in due course.
