### MINUTES OF MC MEETING (VIRTUAL) HELD ON 29.09 2020

	OPENING OF MEETING:				
	TKB opened the meeting by welcoming members. TKB placed before the house the Minutes of				
	Meeting held on 24 <sup>th</sup> . September, 2020. It was unanimously accepted and placed for record. TKB				
	requested SB to chair the meeting.				
2	FORTHCOMING RULE CHANGE FOR PLACEMENT AT FORTHCOMING AGM				
	Convenor SK started the discussion expressing his sincere thanks to President for allowing him to place				
	before the members his observations.				
	SK stated that detailed discussion took place between the Rule change committee members. Valuable				
	inputs are there which to be considered before finalizing the proposed amendments. It is fact that there				
	are lot of contradictions in the existing rules of UWA which need to be addressed properly. This exercise				
	is time consuming. Doing in a hurry will not fetch the desired result.				
	Hence SK proposed that only important new rules and amendments to be placed at AGM. Then before				
	calling EGM the committee can finalise all required changes and place it at EGM.				
	SK also expressed his concern of using Proxy in MC meetings. SK stated using proxy in MC meetings				
	would undermined the ethics of conduction MC meetings. Also proxy is usually used for voting purpose.				
	It would be appropriate to avoid proxy in MC meeting.				
	TKB, taking part in the discussion also emphasized that proxy to be avoided in general MC meeting. It is				
	also observed that proxy is used in a lighter value. TKB suggested proxy to be avoided in normal MC				
	meeting.				
P .	SR also expressed his view about using proxy in a similar manner as SK stated.				
	After discussion at length and considering majority opinions, SB stated that in forthcoming AGM only				
	important rules will be proposed to be amended and two new clauses to be included.				
	New clauses are:				
	a) Refixation of tenure of the committee and sub committees and presentation of accounts.				
	b) Setting up on an independent compliance review committee.
