High Powered Committee for "Design and Safety Audit of Urbana"

During every storm/cyclone in past, window and other defects came to forefront. However, during last Aamphan on 20 May 20, it became extremely fatal when as many windows flew away, glasses broke, many other defects were highlighted by residents

This time, UWA has taken it very seriously and sent 2 mails to BNRI to which no response has been received so far. UWA now decides to set up high powered Committee to get comprehensive Audit of every aspect of Urbana related to design, structure, safety, security and windows etc. done by any reputed Institutional expert agency and based on their report/recommendation to take up appropriately with concerned authorities.

For this purpose, a high powered committee is proposed to be formed with following persons with diverse experience who will be evaluating the right agency and engage with proper brief and work with them to get all aspects audited.

The assignment to the high-powered Committee being mission critical, hence will continue till the objective is fulfilled and all UWA committees (whether current or future) will honor them and co-operate fully to accomplish the dream of every Urbanite. The incumbent President and Secretary will always be the ex-officio member of the committee. The incumbent Governing body will have the liberty to further induct 2 members to this high powered committee but not empowered to remove any of the existing members. To meet the expenses of Audit etc, UWA committee hereby approves upto a sum of Rs 7 lacs from UWA Fund and commits further fund as and when required to fulfill the set objective.
