It was assured that CAM committee will ensure implementation of a proper mechanism of cost apportionment between Phase 1, Phase 2 and Villa segment.</p>

RESOLVED THAT all transaction of Receipts and Payments, irrespective of their mode, must be recorded in the books of accounts. It is further resolved that the final accounts must include Event Wise Income and Expenditure account wherein funds have been specifically raised from members and sponsors for that particular event.

Besides ethical and transparent procurement policy for Goods and services should also be put in place fixing a threshold expense limit beyond which it should apply, like inviting tenders or requirements put in public domain.

CORE AREAS OF ACTIVITIES.

INFRASTRUCTURE REPAIRS AND MAINTENANCE:

Technical Committee Update 2021-22

- The major work of the Central Lawn drainage system, modification and repair was undertaken.
- The Medical Room was renovated and remodeled as a professional Medical facility here in Urbana. This has gone a long way in improving the in-house medical facility with the availability of the services of a nurse and resident doctors and testing facilities.
- When we took over the conditions of the Community Halls and kitchen was in a very bad shape because of the Amphan effect. The Community Halls have all been renovated given a fresh look. All the towers reception areas have also been renovated and the reception sofas repaired.
- Defective TV in Tower 2 reception has been replaced by a new TV
- New TV Installation of at Club Bar has been done, Liquor License has been received and the Club Bar is now in full operation.
- Club House Cooling Tower Ducting repairing has been done
- 6 nos of sand filters overhauling for small & big both swimming pools has been done
- New pump installation for small swimming pool circulation system will be completed on receipt of the pump ordered
- New suction sweeping pump purchase for swimming pool is done
- CCTV Camera Servicing in all Towers, Bungalow Area and Club House has been done & New CCTV Camera installation in Club House Lifts has been done.
- New Camera installation at Tower-6 service lift is under process
- New car wash pump installation with flush water supply to car wash points and water bodies has been done
- All canals & water bodies new drain line installation work is done
- Domestic and Flush water automation system has been completed.
- In Basement 2 Pump Room all pipe lines have been freshly painted and defective valve and pipelines replacement job has been done
- Salt saturation Tank Area painting has been done
- DMF, Softner, Oxidation chamber and Brine Overhauling for WTP System has been done




- Salt Saturation Tank Equity Tank, Aerator Tank, SST & CCT overhauling for STP as also MGF & ACF overhauling at STP has been done
- 5 numbers of new magnetic flow meters installation for Domestic & STP water supply has been done
- New UPS installation in all Towers has been done and the Club House & Main Gate UPS installation has been approved and the job is yet to be completed.
- New Bar Screen Installation at Raw Sewerage Tank has been completed and 2 new lifting pump installation at Raw Sewerage Tank is to be completed on receipt of the pumps that have been ordered.
- New Submersible Pump installation at all 7 towers service floor sump pits will be completed on receipt of the pumps ordered.
- New Garden water supply line from STP to all Towers and Bungalow Area is under process
- Borewell-1 servicing is done & Borewell-3 servicing will be completed within this month
- Solar Cells with Panel shifting from Tower 4 Puja Pandal area to the ground near Tower 5 area has been done. With the sifting of the Solar Panels we will thus have a larger space for our festivities
- New Compactor machine installation for Garbage disposal is done
- Water supply main pipe line replacement from service floor to roof tank for all towers is being done and is under process
- ACB & VCB Servicing for Common areas and Towers is in progress
- Club Library renovation painting job done. Proposal to install more racks for storage of books in the Library had been pending with the authorities and in principal approval has been given by Rahul Todiji. With the new GM, UFM having taken charge the proposal can now be taken forward and the library can then start functioning. Barcoding and issue to books can then start. Aratrika along with MrAnimeshMukherji and Anita Mukherjee have taken the responsibility to get the library functioning.
- Proposal for setting up Electric Vehicle Charging Stations in front of Tower 2 & Tower 3 has been received from M/s EVRE who has seen the site and is ready to set up the EV Charging station on signing of the draft agreement sent by them. The incoming UWA Committee is to take this forward with necessary approvals.
