

Detailed report on the completion of Election Process

1. Vide references quoted above, the outgoing UWA Executive Committee had conveyed its decision to conduct Annual Elections to the UWA Governing Body and for the purpose had decided unanimously to appoint the undersigned as the Returning Officer for these elections.
2. The UWA had also nominated the following Executive Committee members to assist and oversee the smooth conduct of election:
 1. Pradeep Bhatia
 2. Santosh Kumar Ray
 3. Uday Kumar Mukhopadhaya
 4. Gopa Bhabani
 5. Sanju Thakar
 6. Prasad Banerjee
 7. Pradip Sinha
3. After discussions in its first meeting with the Executive Committee members - nominated for the purpose of elections, the election schedule was finalized and notified by the Election Officer vide his Notification Dt.19-03-2019.
4. Subsequently, in its meeting held on 23-03-2019, a two member Election Committee was constituted to assist the Returning Officer in conducting the Election. Two nominated members were:
 - (A). Mr. Bharat Agrawal – Resident of Tower-1, Flat No: 2401
 - (B). Mr. Krishna Deo Tewary – Resident of Tower-7, Flat No: 1606.



5. The above mechanism was put in place and announced vide Election Notices Nos. ELEC/UWA/2019/ III & IV Dt.23-03-2019, setting the Election process in motion.
6. This being the first election for UWA- and that too without having a well documented framework, guidelines and support systems, the whole exercise was a challenge. Therefore, with the sole aim of ensuring a smooth, hassle free, resident friendly - yet free and fair, and legally valid election process – based on hands on feedback coming from the residents through whatsapp groups, , certain modifications were made and announced to extend and expand the scope of user friendly measures. For example, option of E- Voting and Special Voting for those unable to reach the polling booth physically, were expanded to cover more and more voters to help them cast their votes.
7. All election related instructions and notifications were uploaded on the website as well as various whatsapp groups to keep the information flow impeccable and within reach of everyone.
8. While E-Voting closed on 18th evening 5:00PM (IST), physical voting followed on 19th from 8:00 AM to 4:00PM. In all 264 valid votes were polled. While E-Votes totaled to 55 in number, physical voting accounted for 209 votes.
9. Process of counting of Votes – in the presence of two representatives each, from both the contesting teams, was started from 8:00 PM on 19th April 2019 and it continued till 3:10AM in the wee hours of 20th April 2019. Since, there was a tie for two positions – as a precaution, re-counting was redone and checked four times to the satisfaction of all stakeholders, to ensure 'Zero Error' in results.
10. Finally the results were announced and also posted on the digital media. The results are as given below:

11. Now that the election process is over, all the records are sealed and handed over to the election team of the UWA for preserving for future reference. Two sets of ballot papers – 400 Pink and 400 Green, were printed. Out of which 209 each were used. In the Pink Ballot Papers, 2 numbers were missing. Hence, remaining 191 Green blank Ballot papers and 190 pink papers have been left over and are handed over to the election committee of UWA. The E- Ballots after having been printed were mixed with the physical ballot appears. All the used ballot papers(both E- Ballot plus Physical Ballots) are handed over in a sealed condition for preserving the record of this election. All other Election records i.e. Nomination Forms Counterfoils of ballot Papers are also handed over.
12. In all eleven sealed envelopes are handed over to UWA Election team for safe custody of records.
13. Before declaring the election process closed, I will like to record my gratitude to Election Committee members Mr. Bharat Agrawal and Mr. K D Tewary who - in the absence of any support systems, whatsoever, being available for conducting elections, took upon themselves the entire work load – right from ministerial work to IT support to last detail of physical arrangements of logistics. But for them, the task could not have been completed.
14. My thanks are also due to the UWA Governing Body for the faith reposed in me and trusting me with the responsibility of the Returning Officer.



15. I also want to congratulate the new team who have emerged winners after this truly democratic exercise.

With this the process of UWA election 2019 stands closed.
