2) The above names will form the Core Committee. The Convenore & Co-Convenors are free to add other

Members to their Teams as required provided it is unanimously agreed by both.

The only exception being the Core Committees for Social Services, Municipal & Health Services
(which includes Covid related matters)

These can be expanded by the Convenors. In the case of Social Services it is anticipated that many
from previous year's team maybe retained as they had done a good job

also in the previous SC and this had worked independently.

3) SC Convenors are encouraged to arrange and hold their own meetings with UFM or outside vendors / srvice providers as the case maybe. They must however, inform the PST in writing so that the PST can attend such meetings if they wish

4) MOM of each meeting must be forwarded to UFM if meeting is with UFM and to members of the SC within 3 days.

5) In case of any decisions that involve Policy, please do not take any decision on your own without prior discussion with PST and anything major should go through the main Committee
